The Offer Price is expected to be fixed on or around Tuesday, 6 February 2018. Applicants are required to pay the maximum Offer Price of HK\$0.875 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Hong Kong Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Joint Lead Managers (for themselves and on behalf of the other Underwriters) on or before Monday, 12 February 2018, the Share Offer will not proceed.

Applications for the Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.

F. If your application for Public Offer Shares is successful (in whole or in part)
